RESOLUTION 1/51-IBO ON ISLAMIC OFFICE FOR THE BOYCOTT OF ISRAEL

The Fifty-First Session of the Council of Foreign Ministers of the Organization of Islamic Cooperation Under The Theme: (The OIC in a Transforming World) held in Islambul, Republic of Türkiye $21^{st} - 22^{nd}$ June 2025 (25th - 26th Dhu'l-Hijjah1446H);

Proceeding from the principles and objectives of the Charter of the Organization of the Islamic Cooperation (OIC),

Mindful of the existing cooperation and coordination between the Islamic Office for the Boycott of Israel (IBO) at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States in favor of an optimal implementation of the principles and provisions of the boycott of Israel,

Based on all the relevant Islamic resolutions, in particular Res. No. 1/48-IBO, adopted by the 48th Session of the Council of Foreign Ministers held in Islamabad, Islamic Republic of Pakistan, on 22-23 March 2022,

Having considered the Secretary General's report on the IBO,

Decides what follows:

- 1. Recalls the Jakarta Declaration on Palestine and Al-Quds Ash-Sharif, adopted during the Fifth Extraordinary Islamic Summit on Palestine and Al-Quds Ash-Sharif on 7 March 2016, containing commitments to pursue concrete actions to be collectively taken towards the realization of the inalienable rights of the Palestinian People, including calls upon the international community to support the boycott of products produced in or by the illegal Israeli settlements.
- 2. Calls on the Member States and the wider international community to ban the products of the illegal Israeli settlements from entering their markets, take measures against individuals and entities involved in or beneficiaries of the perpetuation of occupation and settlement regime, and include settler leaders, including the hordes of terrorist settlers, on the list of terrorists and criminals wanted for international prosecution by States and international organizations; stresses the need to take legal action vis-à-vis these crimes at all international fora and relevant organizations; and pays tribute to those Member States that have taken action to boycott the products originating from Israeli settlements.
- 3. Invites the Member States to commit to the implementation of the provisions of the Islamic Boycott of Israel and to consider the legislation and the rules and regulations governing the boycott action (general principles of the boycott, the Islamic law, and the OIC Summit and CFM resolutions on the boycott of Israel) as part of their national legislation in force.
- **4. Invites** the Member States to continue to work at the international level to stop all economic and trade activities on settlements, including by inviting the UN High Commissioner for Human Rights to annually update the list of international companies operating illegally in Israeli settlements on occupied Palestinian territory, and to

- continue calling on these institutions to stop doing business with Israel and show respect for the principles of international law and human rights.
- **5. Stresses** the primacy of the "International Convention on the Suppression and Punishment of the Crime of Apartheid" as one of the major international instruments to counter racist policies of the Israeli regime; encourages all signatories of the Conventions among the OIC Member States to use International for a as well as bilateral avenues to call for its universal ratification of the Convention.
- **6.** Welcomes non-member States, which took positions against the Israeli colonial and occupation system and further invites non-member states to make similar steps in this regard.
- 7. Welcomes and supports the efforts of civil society in support on the campaign of boycott of colonial settlement activities and condemns the legislations passed in a number of states to ban and criminalize their activities in this regard.
- **8. Requests** the IBO with the assistance of professional consultant in consultation with the State of Palestine to produce an updated and credible list of products of illegal Israeli settlements as a common reference for the OIC Member States in implementing this resolution at the national level.
- **9.** Commends the existing cooperation between the IBO at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States in favor of an optimal implementation of the principles and provisions of the boycott of Israel.
- **10.** Expresses strong support to the IBO to enable it to perform its duties and tasks aimed at increasing the efficiency of the boycott of Israel in Islamic States.
- 11. Requests the Secretary General to appoint a Director General of the Islamic Office for the Boycott of Israel within the Department of Palestine and Al-Quds Affairs at the General Secretariat of the Organization, to follow up on the implementation of this resolution, and to operationalize the role of the OIC General Secretariat in this regard.
- 12. Requests the Secretary General to follow up the implementation of the present resolution and to report thereon to the 52nd Session of the Council of Foreign Ministers.
